Lecture by Prof. Thomas Straubhaar on January 11, 2024: "The 3-E of a Universal Basic Income from an economic perspective: easy, effective and efficient"

Prominent economist and basic income advocate Prof. emeritus Thomas Straubhaar will be visiting Freiburg in January 2024 at the invitation of FRIBIS to deliver an evening lecture. (The lecture will be conducted in German. The title has been translated for your convenience.)

The lecture will address the question of how a sustainable tax and social policy should be shaped in today's complex world. Prof. Straubhaar believes it should be as simple and transparent as possible, avoid risks, promote learning and be adaptable to the changing ways of life and work. He claims that the Universal Basic Income fulfils these criteria. In his lecture Prof. Straubhaar will show how a UBI could streamline the transfer system, guarantee social security and efficiently achieve social policy objectives.
